Cali Greek Picnic Vendor's Contract

The parties to this contract are **California Greek Picnic (CGP)** and _____
(hereafter "Vendor").

Whereas, **CGP** is hosting an event known as **Cali Greek Picnic** to occur in Los Angeles, California on 6/15/19 and has the right to license concessions to vend at and during the Event.

Whereas, Vendor desires to vend or advertise (type of goods) _____
_____ at and during said Event(s), and

Whereas, Vendor will pay Host the sum of **\$180** for a license to vend at and during said Event,

Now, therefore, the parties agree as follows:

1. Vendor shall have access to the location agreed upon by the parties no less than 2 hours before the Event's commencement for setting up Vendor's vending station, goods, and other things necessary and reasonable to vending at the location.
2. Vendor will be provided with a vending station that includes tent (picnic only), table and two chairs. Vendor must be completely setup at least 30 minutes before the start of the event. (Food trucks excluded from item #2)
3. Vendor shall not vend any goods or services other than those described herein at and during the Event without the Host's written consent.
4. Vendor's vending station shall be clean and orderly; and shall comply with all applicable laws and regulations.
5. Vendor's staff may announce the availability of the goods to be vended only while they are within the confines of the vendor's location.
6. Vendor's staff shall be clothed and groomed in a clean, neat fashion and shall conduct themselves in an orderly fashion.
7. Vendor shall have access to the location for up to **1** hour after the Event to dismantle and remove all things brought to the location by Vendor. Vendor shall leave the location clean of trash and substantially in the condition it was before Vendor occupied it.
8. Vendor hereby agrees to indemnify and hold harmless the Host against any damages or claims that may arise in connection with Vendor's presence at the Event and Vendor's activities of any kind.
